Report Explanatory Note:

The penalty point and disqualification data are compiled from the NVDF (National Vehicle and Driver Database). The NVDF is the source of record for driving licence, penalty point and disqualification data.

Penalty point and disqualification data are sent electronically to the NVDF on a weekly basis from An Garda Síochána (AGS) and the Courts service. This data is made up of:-

- Offences resulting from paid Fixed Charged Notices (FCNs) from AGS
- Offences resulting from court appearances from the Courts Service

The offence statistics in this report are compiled against this data sent from the courts and AGS. Please refer to the First Schedule to the Road Traffic Act 2002 to get further detail on the basis of penalty points and offences. The up-to-date version of the 2002 Act can be found on the Law Reform Commission website.

The figures are a snapshot as of last day of the previous month and are the total number of penalty point offences recorded on the offender's driving licence at that point in time. It is important to note the figures are the total number of offences at that point in time and not just the offences for the month in question.

Penalty points are recorded on the offender's driving licence and remain on the licence for a period of three years.
