



## New requirements for L category vehicles (two-wheel, three-wheel vehicles and quads) on 1 January 2021

From 1 January 2021 new requirements apply to L category vehicles. These are:

- New emissions test procedure
- New Euro 5 emission limits
- New Sealed House for Evaporation Determination (SHED) test limits<sup>1</sup>
- New durability test
- New on-board diagnostic (OBD) tests
