Dear candidate ADI,

The application should be completed after reading the following notes:

- You must complete a Garda vetting invitation form. Once your completed application. form and all required documents are received and checked you will be issued with a link by email where you can access your online eVetting form. Complete this online for processing by the Garda National Vetting Bureau. This will help the RSA assess if you meet the "person of good repute" criteria. Among the offences which will be considered to make a person unsuitable are murder, manslaughter, serious assault, drug trafficking, fraud and serious traffic offences. This form must be completed and returned to the RSA using the enclosed envelope.
- Please include your 6 digit Tax Clearance Access Number and a copy of your driving licence.
- Please return the completed application form, ensuring that you tick  $(\sqrt{})$  each driving licence category that you wish to give instruction (together with two passport style photographs) to the: Driver Education Section, Road Safety Authority, Moy Valley Business Park, Primrose Hill, Ballina, Co. Mayo, F26 V6E4.

\*The driving instruction industry was regulated on 30th April 2009. It is now illegal to give instruction unless you are a Fully Qualified Approved Driving Instructor.

The Information Pack is available to download at www.rsa.ie to help you to prepare for the three ADI qualification stages.

The objective of regulating the industry is to standardise instruction and give the ADI instructor a leading role in developing better drivers. The conditions of membership have been carefully framed to allow for a quality standard to be met with the minimum of inconvenience to the applicant.

#### Question 1 - 4

Please fill in the information in capitals, clearly and correctly.

#### **Question 5**

Please provide details of contact telephone numbers at which the RSA may contact you. Contact will include group text messages by way of an alert from time to time

#### Question 6

Please Note: The Authority reserves the right to reject an email address that may be construed as being either offensive or insulting, and request a more suitable or more businesslike, address.

#### **Question 7**

Please confirm whether or not you are an employee or self-employed.

#### Question 8

PPSN is your Personal Public Service Number, for an employee you can find it on your P60 or certificate of tax credits and standard rate cut-off point. If you do not know your PPSN, you can contact your local office of the Department of Social Protection.

Each applicant is required to submit a current tax clearance access number issued by the Revenue Commissioners under the provisions of section 1095 of the Taxes Consolidation. To obtain a tax clearance access number you will need to register with ROS (Revenue On-Line Service).

Please tick the relevant box for each offence. If the answer to any of the questions is 'yes' please provide date of conviction and sentence received in the space provided. A Garda Vetting invitation form must be completed and returned with your application. If your application is in order you will then be issued with an email containing a link to your online eVetting form where you will fill in all your details online. Failing to provide any detail in relation to either convictions you may have, (even in the distant past) or addresses at which you lived, may result in your application being delayed or refused. Please note Garda vetting process may take some time, you will be invited to undergo the Stage 1 Theory test, once the Garda vetting information has been received from An Garda Siochana.

The theory test provider Prometric Ireland Ltd. should be contacted regarding the date, time and location of your theory test. These details will be clearly outlined in an email which will issue to you once your Garda vetting information has been received from An Garda Siochana.

Stage two- driving test and stage three - instruction ability test will be held in the locations outlined in question 16.

#### **Recognition of Existing Qualifications**

Please see in your information pack what is required by the RSA to assess your existing qualification. Please also note the standards of service providers, quality assurances in place by the RSA. You should contact the ADI Unit in relation to recognition of prior qualifications. An assessment will only be be made once you submit your application form and all required documentation and you will be notified of the outcome.

#### Fee:

Once you make a completed application to the Road Safety Authority (see checklist below) to become an ADI and your Garda vetting application has been processed and approved (Please note that this can take approximately 6 − 8 weeks) you will receive an email containing an eligibility number and the details on how to book your ADI Stage 1 Theory Test by telephone or online. It is at this stage that you will make payment for ADI Stage 1 Theory Test directly to Prometric (company that you will book your ADI theory test with). This fee is currently €150.

### Cancelling your test:

#### **Important**

Please note 10 clear working days notice of cancellation must be given, otherwise the examination fee is forfeit. A limit of two cancellations (within the 10 days period) applies to each stage of the examination process after which any fee will be forfeit
