Declaration by Trainee Licence Applicant

- I apply for the issue of a Trainee Driving Instructors Licence and agree to the conditions of the scheme.
 I confirm that I have received a minimum of 20 hours initial practical training from my ADI sponsor in the required competency areas and enclose my fee of €50 (cheque/postal order/ban draft made payable to ADI Unit, Road Safety Authority) together with the signed certificate of completion of initial training.
- I declare that the information I have given is to the best of my knowledge true and accurate and I consent to the RSA making enquiries from appropriate authorities to verify the information given.
- My driving licence is valid. I have not been disqualified from holding a driving licence, in the State, or by a Member State of the European Communities or the European Economic Area.
- I have not been disbarred from giving driving instruction by the competent authorities in a Member State of the European Communities or the European Economic Area.
- I confirm that I hold proper insurance cover for the purposes of carrying out driving instruction. The
 vehicles I will provide for driving instruction are road worthy, properly maintained and in full compliance
 with the road traffic act.
- I agree that a minimum of 20% of the training I provide to learners will be under the direct supervision of
 my sponsoring ADI and will record all learner training provided in the "Record of Training provided" Log.
 I understand that this is a legal requirement.
- I will only give training in the category that I have been approved to provide trainee driving instruction in and I will ensure that my ADI Sponsor continues to hold this category also.
- I will display my Trainee Licence clearly in the vehicle during all learner tuition lessons, whether or not I am being supervised at the time.
- I understand that I am entitled to apply for only one trainee licence which is valid for a maximum of six months from date of issue.
- I accept that it is not possible to change to a different ADI Sponsor without advising RSA Driver Education in writing and receiving written approval to do so from the RSA in advance of any change.
- I understand that the holder of a Trainee Licence is not permitted to provide EDT (Essential Driver Training) sessions or give IBT (Initial Basic Training) instruction to motorcyclists. However, I can accompany a qualified ADI during either type of session/lesson providing the learner agrees.
- I understand that my application for approval as an RSA Approved Driving Instructor requires that I
 must complete the entire qualification and registration process within 24 months of passing my Stage
 1 Instructors theory test.
- I understand that I can apply for the stage 3 test and return my Trainee Licence, identity card and the completed "Record of Training provided" Log at any stage during the six-month validity period or at the end of the six-month validity period and agree to return these to: **Driver Education Section, RSA, Moy Valley Business Park, Primrose Hill, Ballina, Co Mayo**
